July 8, 2006: called their 800 number and was talked into doing a \$495 nationwide asset search. He said he'd have results in 10 days but it could be a lot faster. August 8, 2006: Nothing. When I called, they told me "it's still in research." So I did an Internet search and found out that EVERYONE'S search is "in research." In fact, it is IMPOSSIBLE for him to do what he says because you can't find bank records via public records searches (which is what he's licensed to do). So 100% of his clients get " nothing found" because it's impossible for him to deliver on his claim. Even famed fraud investigator Barry Minkow (of ZZZ-Best fame and he also appeared on 60 minutes) was also defraud by this con artist and is pissed. Minkow smelled a rat and called his bank just before it was too late. I sued him in small claims court and won \$500 in actual damages plus \$2,000 in punative damages. So the court was convinced it was a fraud operation. But that's just me. I got his bank records and it shows he rips people off at the rate of \$40,000 per month. He's been doing it since 1999.
